GERMAR RUDOLF (ED.) Â· DISSECTING THE HOLOCAUST We must understand the disarray of Germany's accusers in the face of revisionism's successes. For half a century they have sincerely believed that the tragedy undergone by the Jews during the Second World War was of exceptional seriousness and magnitude, whereas, when reduced to its proper proportions that is, without genocide and without gas chambers their tragedy was just one of many other tragedies of that terrible conflict. and that the
